### A simple and supportive way to enhance AEGC

The AEGC 250 Club was set up in order to provide 'wish list' items for the Club as well as rewarding those who make monthly contributions. Half the money collected monthly is put into a pot for distributing each quarter to 4 lucky winners and the other half set aside for the 'wish list'.

In 2018 the Trustees of the 250 Club purchased the new patio furniture and the defibrillator as well as further money to the Gardening Club to enhance the look of the course, particularly behind the 4<sup>th</sup> Green. In 2018 the 250 Club purchased the patio furniture, money to the gardening club and in 2019 contributed to the new Howdidido screen in the Spike bar.

Opening Sides – March

Captain's weekend June or July

Closing Sides – October

Members of the AEGC 250 Club buy monthly 'share' by setting up a monthly standing order with each share costing £5 and gives the member a number for the quarterly draw. ## **AEGC 250 Club Constitution**

---

1. The name of the prize draw is the AEGC 250 Club.
2. The purpose of the draw is to raise funds for the sole benefit of Alderley Edge Golf Club.
3. The draw will be administered by four Trustees, appointed by the Chairman of the Club and ratified by the AGM of the Club. At least one of the Trustees must be a director of the Club and another Vice President.
4. The level of the prizes will be determined by the Trustees.
5. The draw will be open to anybody aged 16 or over. A purchaser of a share becomes a participant in the draw. Participants are entitled to hold any number of shares.
6. The number of shares in the draw shall be unlimited and each share shall be allocated a unique number. Participants may confirm the number of their allocated share (s) by contacting the Trustees.
7. The subscription for each share is £5 per month payable monthly in advance by standing order. To be eligible for a quarterly draw, a completed standing order must be received **BEFORE** the first day of the month of the draw period eg to be received by 31<sup>st</sup> March for the April to June draw.
  - 1<sup>st</sup> Quarter - 1<sup>st</sup> April to 30<sup>th</sup> June
  - 2<sup>nd</sup> Quarter - 1<sup>st</sup> July to 30<sup>th</sup> September
  - 3<sup>rd</sup> Quarter - 1<sup>st</sup> October to 31<sup>st</sup> December
  - 4<sup>th</sup> Quarter - 1<sup>st</sup> January to 31<sup>st</sup> March
8. There shall be a draw made in each quarter using an automatic random number generator or other such means as the Trustees deem appropriate. All participants are entitled to attend the draws, which must be held in the presence of at least 2 Directors of the Club, on such occasions and times as the Trustees shall deem appropriate. The Annual draw will take place in the 3<sup>rd</sup> Quarter.
9. Winners will be paid by cheque, which will be sent to the last known address held by the promoter. It is the responsibility of the participant to advise the Trustees of any change of address. Any prize cheque not cashed within 6 months will be deemed a donation to AEGC. A list of prize winning numbers will be published on the Club website.
10. The Trustees will not pay a prize to any participant other than the purchaser of the winning share.
11. No participant will be included in the draw if the subscription has not been received. It is the responsibility of each participant to make sure they have paid their subscription. The Trustees reserve the right to reallocate any number where payment has not been received.
12. Participants can cancel their entry in the Lottery at any time by giving one month's written notice to the Trustees via the Club Office. Any decision by the Club to end the draw will also be by one month's notice to all participants. By entering the draw Participants agree to be bound by the constitution of the AEGC 250 Club.
13. Under no circumstances can subscriptions be refunded.
14. The Trustees will determine any dispute. An appeal may be made to the Club Chairman whose decision shall be final.
15. The draw is intended to be a 'Small Society Lottery' under the provisions of the Gambling Act 2005, Section 19.
16. The Directors of Alderley Edge Golf Club may amend or vary the rules of the draw at any time. The rules of the draw will be available via the Club website. Changes will be notified to Participants via the Club website.
