The AEGC 250 Club was set up in order to provide 'wish list' items for AEGC as well as rewarding those who make monthly contributions. Half the money collected monthly is put into a pot for awarding each quarter to 4 lucky winners and the other half set aside for the 'wish list'.

As some examples in recent years, the Trustees of the 250 Club have purchased new patio furniture and a defibrillator as well as contributing towards the cost of course machinery and new tee mats. It has also provided money to the Gardening Club to enhance the look of the course.

Normally, the draws are held at AEGC social events:

Captain's Drive – 1st January

Opening Sides – March

Captain's weekend- June/July

Closing Sides – October

Clearly, 2020 was an exception, and for all the wrong reasons, but nevertheless four draws were held in accordance with 250 Club requirements and will continue as such in 2021.

Members of the AEGC 250 Club buy 'shares' by setting up a monthly standing order or direct debit, with each share costing £5 and providing the member with a number for the quarterly draw. AEGC 250 Club Constitution

1. The name of the prize draw is the AEGC 250 Club.
2. The purpose of the draw is to raise funds for the sole benefit of Alderley Edge Golf Club.
3. The draw will be administered by one of the Trustees appointed by the Chairman of the Club and ratified by the AGM of the Club. At least one of the Trustees must be a Vice President of the Club.
4. The level of the prizes will be determined by the Trustees.
5. The Trustees reserve the right to determine the number of prize winners for each draw.
6. The draw will be open to anybody aged 16 or over. A purchaser of a share becomes a participant in the draw. Participants are entitled to hold any number of shares.
7. The number of shares in the draw shall be unlimited and each share shall be allocated a unique number. Participants may confirm the number of their allocated share (s) by contacting the Trustees.
8. The subscription for each share is £5 per month payable monthly in advance by standing order or direct debit. To be eligible for a quarterly draw, a completed standing order or direct debit must be received **BEFORE** the first day of the month of the draw period eg to be received by 31st March for the April to June draw.
 - 1st Quarter - 1st April to 30th June
 - 2nd Quarter - 1st July to 30th September
 - 3rd Quarter - 1st October to 31st December
 - 4th Quarter - 1st January to 31st March
9. There shall be a draw made in each quarter using an automatic random number generator or other such means as the Trustees deem appropriate. All participants are entitled to attend the draws, which must be held in the presence of at least one Director of the Club, on such occasions and times as the Trustees shall deem appropriate.
10. Winners will be paid by cheque or by electronic bank transfer, which will be sent to the last known contact details held by the promoter. It is the responsibility of the participant to advise the Trustees of any change of contact details. Any prize cheque not cashed within 6 months will be deemed a donation to AEGC. A list of prize-winning numbers will be published on the Club website.
11. The Trustees will not pay a prize to any participant other than the purchaser of the winning share.
12. No participant will be included in the draw if the subscription has not been received. It is the responsibility of each participant to make sure they have paid their subscription. The Trustees reserve the right to reallocate any number where payment has not been received.
13. Participants can cancel their entry in the Lottery at any time by giving one month's written notice to the Trustees via the Club Office. Any decision by the Club to end the draw will also be by one month's notice to all participants. By entering the draw, Participants agree to be bound by the constitution of the AEGC 250 Club.
14. Under no circumstances can subscriptions be refunded.
15. The Trustees will determine any dispute. An appeal may be made to the Club Chairman whose decision shall be final.
16. The draw is intended to be a 'Small Society Lottery' under the provisions of the Gambling Act 2005, Section 19.
17. The Directors of Alderley Edge Golf Club may amend or vary the rules of the draw at any time. The rules of the draw will be available via the Club website. Changes will be notified to Participants via the Club website.
